# REPORT OF THE TRUSTEES FOR THE YEAR ENDED 5 APRIL 2018

The directors present their report with the financial statements of Loughborough Junction Action Group for the year ended 5 April 2018.

## STRUCTURE, GOVERNANCE AND MANAGEMENT

Loughborough Junction Action Group is a registered charity (No 1150852) and also a company limited by guarantee not having a share capital (No 08100566). Loughborough Junction Action Group (LJAG) is a company limited by guarantee, incorporated on 11 June 2012, governed by its Memorandum and Articles of Association. It registered as a Charity with the Charity Commission for England & Wales on 18 February 2013. Prior to this Loughborough Junction Action Group existed as a community group, which was established in 2008.

The Charity is run by the Board of Trustees, detailed above. The Trustees meet regularly to review the performance of the Charity, consider risks and issues affecting the Charity, and to review the future plans of the Charity.

Appointment of new Trustees is governed by the Memorandum and Articles of Association, as amended by special resolution on 8 February 2013.

#### **RISK MANAGEMENT**

The Trustees actively review the major risks the Charity faces on a regular basis including risks to its future grant income. The Trustees have also examined other operational and business risks faced by the Charity and have established systems to mitigate these risks.

# **RESERVES POLICY**

The Trustees monitor the grants that it receives and in order to continue its work maintains a reserve of £500.00

#### PUBLIC BENEFIT

The Trustees confirm that they have complied with their duty in Section 17 of the Charities Act 2011 to have due regard to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Charity's aims and objectives and planning its future activities.

The Trustees have considered the Charity Commission's guidance on public benefit and they believe that the support provided to the Loughborough Junction Action Group allows its objectives to be met for the benefit of those who live and work in Loughborough Junction.

#### LOUGHBOROUGH JUNCTION ACTION GROUP REPORT OF THE TRUSTEES FOR THE YEAR ENDED 5 APRIL 2018

#### **OBJECTIVES AND ACTIVITIES**

The objectives of the charity are the advancement of education, the relief of poverty and improvement of the natural environment in the Loughborough Junction area.

The charity seeks to do this through its own work and also through the support of any charity in Lambeth whose objectives are in line with these.

The main activities during the year were to use grants received to pursue these objectives.

#### ACHIEVEMENTS AND PERFORMANCE

During the year the charity had an income of £75,581 comprising grants, sales and donations. This was used to run the Loughborough Farm, the Farm Café, the Grove Adventure Playground, craft workshops and community engagement activities in the Loughborough Junction Area

#### The work of LJAG

The Loughborough Junction Action Group (LJAG) is a social action charity based in the Loughborough Junction area of south London.

We aim to improve the environment of Loughborough Junction and the lives of the people who live there.

The charity works to establish Loughborough Junction as a resilient and cohesive community and to foster a culture of volunteering. It is our mission to make Loughborough Junction a great place to live and work. We wish to inspire pride and a sense of place in Loughborough Junction. We work to achieve this through projects focused on skill-sharing, community gardening and food growing, place-making and community events.

#### Funding

During the financial year to 5 April 2018 we received funding from the following organisations: Battersea Power Station Foundation; Co-op's 1 per cent scheme; Evening Standard Dispossessed Fund; the Lambeth Forum Network; Fresh Leaf Foundation; Locality; Metropolitan; the Peter Minet Trust; and the People's Health Trust.

Since the end of the financial year we have raised a further £15,500 from the Lambeth Community Fund, Metropolitan housing association, L&Q housing association and the Lambeth Youth Mayor's Fund.

We would particularly like to acknowledge the help we have received this year from Sarah Coyte our Capacity Building Officer at the Lambeth Forum Network; Tom Rumble, Sonia Baralic and Tom Bridgman from Lambeth council's regeneration team. We would like to pay a special tribute to Councillor Matt Parr who died in July. He was a great supporter of LJAG and helped to establish the Loughborough Farm and helped our campaign to reopen and save the Grove Adventure Playground.

#### The Grove Adventure Playground

Our campaign to reopen the Grove Adventure playground in Gordon Grove has been LJAG's biggest project this year. LJAG has supported a group of local residents and parents opposed to the permanent closure of the Grove Adventure Playground. The playground had been closed for three years.

The group feels that in an area where knife crime and gangs are a constant worry, parents and children need access to safe, affordable, and well-run supervised play.

In June LJAG signed a three year meanwhile lease on the Grove Adventure Playground from Lambeth council at a peppercorn rent. The playground structures and building then had to be recommissioned so they were safe to use. Following a monumental volunteer effort and with help from corporate volunteer teams organised by Community Southwark we were able to reopen the playground for supervised play during the summer 2018 holiday.

The playground has been staffed by a play leader and three additional play workers and has been open Monday to Friday from 10.30am to 5.30pm. Over 125 children have registered and daily attendance is around 50.

During the first week the charity BuildUp, which designs and builds playground structures with young people, built an outdoor kitchen and firepit. The project will be completed on two Saturdays in October and in the October half-term holiday. In addition, in the third week of the summer playscheme, a team of young people on the National Citizenship Scheme, The Challenge, ran a games day and produced a book of games for future use.

We would like to thank all the local businesses who contributed towards the cost of providing the children and young people with healthy snacks during the summer playscheme.

Two volunteers Leah Hargreaves and Nick Lewis deserve particular thanks for the effort they have both contributed to reopening this magical playground.

The Lambeth council draft masterplan for Loughborough Junction proposes rebuilding the Marcus Lipton Youth Centre on the Grove Adventure Playground site in order to free up the current Marcus Lipton site for housing. This plan would result in the permanent closure of the Grove Adventure Playground and the end of supervised play in Loughborough Junction.

Lambeth council is currently working on a consultant's brief to look at the future of the two sites and the adjoining Elam Street Open Space.

LJAG, with funding from Locality, commissioned architects Tom Dobson of Public Works and Ashvin de Vos of Variant Office to look at how the Grove Adventure Playground and the Marcus Lipton sites could be redeveloped to provide an income to continue the work of the Marcus Lipton Youth Centre and to continue to provide much needed supervised play for children and young people between the ages of six and 14. The report was submitted to Locality in April and LJAG hopes that the report will inform the future of the two sites. LJAG would like to thank Tom Dobson and Ashvin de Vos for the preparation of a very professional report which was prepared on a shoestring budget.

#### LJ Neighbourhood Forum

The Neighbourhood Planning Forum is a local forum facilitated by LJAG, which met monthly on the last Wednesday of the month. Its terms of reference are to deliver the Loughborough Junction Plan; encourage and facilitate public realm improvements; and investigate the possibility of working towards a Neighbourhood Plan.

This year the LJ Neighbourhood Forum made a submission to Lambeth council on its consultation on changes to the Local Plan. We also submitted to Lambeth council our opposition to the boundary of the proposed Herne Hill Neighbourhood Plan. The Forum and LJAG felt that the proposed boundary extended too far into Loughborough Junction and would damage our community's ability to continue to promote Loughborough Junction as a distinct neighbourhood in its own right; improve the town centre; and support our business community, especially those based in the railway arches. We were gratified that Lambeth council agreed with our position.

#### Improvements to public realm

LJAG was represented on Councillor Jenny Brathwaite's steering group that has worked on public realm improvements in the area. These have included major works by the 7 Bridges project on the railway bridge over Loughborough Road which has become a major local landmark.

Earlier this year public realm improvements were completed at the entrance to Wyck Gardens in front of The Platform and have provided an attractive outdoor seating area for the Loughborough Farm café.

Cllr Brathwaite's committee has not met since February 2018 and we are seeking clarification on proposed improvements to the junction of Coldharbour Lane/Hinton Road/Loughborough Road.

#### The Loughborough Farm and Cafe

The Loughborough Farm is a successful community food growing project on a piece of once derelict land on Loughborough Road. The Farm is open twice a week on Tuesday and Saturday afternoons and our popular Saturday session is often attended by as many as 20 volunteers.

On 31 August 2018, the Farm was five years old and by July we had clocked up 10,000 volunteer hours, worth £102,000 at the London Living Wage.

During this financial year the project was funded by the income generated from sales and donations and we received funding from the Peter Minet Trust and the Battersea Power Station Foundation. This has allowed us to continue to fund our hard-working part-time project co-ordinator, Emily Myers. Since the financial year end we have received a grant of £9,900 from the Lambeth Community Fund to continue to run the Farm and the Café.

Wish You Were Here (WYWH), led by volunteer Karen Hooper, continued to connect with three GP surgeries, the Harbour Recovery Centre, a local hostel and others working to help people to feel included.

Thanks to our many volunteers, in particular Oli Austen and Migle Pikelyte, who have been leading many Farm sessions and Geof Fung who will be leading the group which will design the new Farm which will emerge from LJ Works (see below).

The Farm continues to support food growing at the Marcus Lipton Youth Centre where a group of young boys, ages 10 and 11, are learning about food growing, cooking and healthy eating; at the Moorlands Estate allotment and nature garden where Metropolitan

housing association has funded the Farm to engage with residents; and at the Southwell Road Residents' Garden where the Farm holds a monthly gardening session.

A monthly market stall is held outside the Platform on the first Saturday of the month organised by Farm volunteers Charlotte O'Connor and Johanna Gilmour.

The Farm runs a popular café at the Platform in Wyck Gardens which is open for lunch on Thursdays and Fridays. The Farm Café is run by Charlotte O'Connor, ably assisted by Johanna Gilmour, and a band of dedicated volunteers.

The Farm Café has received funding from the Evening Standard Dispossessed Food Waste fund.

On Fridays local chefs are invited to cook and as a result the café has been able to provide a wide choice of delicious meals which have included dishes from Zimbabwe, Italy, Kerala, Greece and Pakistan.

The Farm management committee meets monthly on the first Wednesday of the month and there are active sub-groups working on DIY projects and crop-planning.

#### LJ Works

LJ Works is the £2 million affordable workspace scheme on the Loughborough Farm site funded by a £1.64 million grant from the Mayor of London's Regeneration Fund and Lambeth council. The architect is Public Works working with 00 Architects and is led by long-time Farm volunteer Tom Dobson.

After delays of over a year, work started on site in the middle of August 2018 and is due to be completed in xxxxx.

The contractor is West Norwood-based H A Marks and during the building work, the Farm will continue in a dedicated fenced off section of the site. A new Farm will be built in the spring of 2019 with funding from the Western Riverside Environmental Foundation (WREF) when new raised beds will be built.

Lambeth council has set up a steering group of local people to advise on the development. The steering group includes local councillors, LJAG, the Loughborough Farm, LEMB, LETRA and Marcus Lipton Youth Centre. The steering group meets on the second Thursday of the month at the Marcus Lipton Youth Centre and is open to the public.

LJ Works will be managed initially by Meanwhile Space CIC. However, it is Lambeth's intention to hand the management of the site to the community steering group within five years.

#### The 7 Bridges

The 7 Bridges is an arts-led regeneration project led by LJAG volunteer Walter Reed. Loughborough Junction's railway bridges are the area's defining feature. The 7 Bridges project aims to bring them alive with, colour and art. The second bridge – the first is on Cambria Road – over Loughborough Road was completed as part of the planned public realm improvements. The bright orange bridge announces to everyone passing through that this is Loughborough Junction. Walter Reed has worked with a group of local artists and the bridge celebrates our common African ancestry.

In January, the 7 Bridges Project, in partnership with Urban Growth and with funding from Open Orchard Project, extended the Loughborough Farm's small orchard in Wyck Gardens as part of Ion Gardens' Roots Down Project. Twenty nine fruit trees were planted to form a promenade through Wyck Gardens from Metropolitan housing association's development South West 9 in Barrington road.

#### Loughborough Junction Business Association

A Christmas Market was held at Sunshine International Arts on 2 December 2017. The Christmas Market has now become an annual feature of life in Loughborough Junction.

LJAG trustee Stephen Bellas has agreed to take on the task of reviving the Loughborough Junction Business Association.

#### **Craft workshops**

Funding for trustee Hazel Watson and former trustee Maude Estwick's popular craft workshops ran out in December 2017. However, new funding has been obtained from housing association L&Q and the craft workshops will resume soon, this time at the Grove Adventure Playground. During the year the charity had an income of £71,766 comprising grants, sales, donations and bank interest. This was used to fund health and well-being projects, the Loughborough Farm café, craft workshops and community engagement activities in the Loughborough Junction area.

LJAG would like to thank the very many volunteers who have given their time over the last year. Without them, none of this work would have been possible.

# The Future

The Trustees have identified the following four priorities:

-Skill sharing

-Greening

-Place-making

-Community events

Skill sharing to include peer-to-peer mentoring; training initiatives including at the Loughborough Farm and elsewhere; workshops for building craft and small business skills; developing volunteer opportunities and skills.

Greening to include continuing support for the work and development programme at the Loughborough Farm; supporting local parks and green spaces and friends' groups; running street gardening activities.

Place-making continuing support for the joint LJ Neighbourhood Planning Forum working on the implementation of the Loughborough Plan and the public realm improvements; arts-led regeneration; planning.

Community events to include festivals and health days.

#### Statement of Directors' and Trustees' Responsibilities

#### LOUGHBOROUGH JUNCTION ACTION GROUP NOTES TO THE ACCOUNTS AT 5 APRIL 2018

### **1** Accounting policies

#### Basis of preparation of the accounts

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention with the exception of investments which are included at market value, as modified by the revaluation of certain assets.

The charity has taken advantage of the exemption from the requirement to produce a cash flow statement.

The particular accounting policies adopted are set out below.

#### Accounting convention

The financial statements are prepared, on a going concern basis, under the historical cost convention.

#### **Incoming resources**

Grants and donations are recognised where there is entitlement, certainty of receipt and the amount can be measured with sufficient reliability.

Deferred income represents amounts received for future periods and is released to incoming resources in the period for which it has been received. Such income is only deferred when the donor specifies that the donation must only be used in future accounting periods or the donor has imposed conditions which must be met before the charity has unconditional entitlement.

Investment income is recognised on a receivable basis.

#### **Resources expended**

Liabilities are recognised on the accruals basis in accordance with normal accounting principles, modified where necessary in accordance with the guidance given in the Statement of Recommended Practice for Accounting and Reporting (revised June 2008) issued by the Charity Commissioners for England & Wales.

# Charitable activities

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

#### **Governance costs**

Governance costs include costs of the preparation and examination of the statutory accounts, the costs of trustee meetings and the cost of any legal advice to trustees on governance or constitutional matters.

#### Taxation

As a registered charity, the company is exempt from income and corporation tax to the extent that its income and gains are applicable to charitable purposes only.

#### Fund accounting

Unrestricted funds are donations and other incomes received or generated for the objects of the charity without further specified purpose and are available for general funds.

Restricted funds are to be used for specific purposes as lay down by the donors. Expenditure, which meets these criteria, is identified to the fund, together with a fair allocation of management and support costs.

# 2 Winding up or dissolution of the charity

If upon winding up or dissolution of the charity there remain any assets, after the satisfaction of all debts and liabilities, the assets represented by the accumulated fund shall be transferred to some other charitable body or bodies having similar objects to the charity.
